

Lilburn Farmers Market Booth for a Cause 2018 Overview and Application

Each week at market we will provide an opportunity for a non-profit organization to host a booth at the market to outreach to our market customers for the purpose of: 1) providing an opportunity for our customers to learn about local organizations; 2) supporting non-profits in our community; 3) providing a fund raising venue for the non-profit organization by selling products that do not compete with those sold by a paying vendor.

- Non-profits will be assigned on a case by case basis and should be reserved prior to the market season in order to be added to the market calendar of events
- Non-profits with a strong membership base in the greater Lilburn area will be assigned higher priority.
- The Market will provide a 10 x 10 space. Participants must provide their own tent/canopy, own chairs, booth displays, bottled water, coolers, ice and dispose of their garbage.
- Supplies: You are responsible for providing their own equipment for the market. However, a limited number of some items are available on a first come/first serve basis, for a fee.
 Fees are due on receipt of rented items. Please let us know prior to market if you need any items.

- Fundraising efforts shall be limited to products that does not compete with regular market vendor sales.

- Non-profits must have a signed Hold Harmless Clause on file to participate in the Lilburn Farmers Market.
- Non-profit booth staff must arrive no later than 3:45 pm to set up their booth and stay until 8 pm.

The market is every Friday from June 1st to August 31st from 4 pm to 8 pm.
