



Lilburn Farmers Market Non-Profit Fundraiser Booth 2015 Overview and Application

Each week at market we will provide an opportunity for a non-profit organization to host a booth at the market to outreach to our market customers for the purpose of: 1) providing an opportunity for our customers to learn about local organizations; 2) supporting non-profits in our community; 3) providing a fund raising venue for the non-profit organization by selling bottled water or products that do not compete with those sold by a paying vendor.

- Non-profits will be assigned on a case by case basis and should be reserved prior to the market season in order to be added to the market calendar of events
- Non-profits with a strong membership base in the greater Lilburn area will be assigned higher priority.
- The Market will provide a 10 x 10 space. Participants must provide their own tent/canopy, own chairs, booth displays, bottled water, coolers, ice and dispose of their garbage.
- Fundraising efforts shall be limited to bottled water or products that does not compete with regular market vendor sales.
- Please see Market Policies and Guidelines at www.lilburnfarmersmarket.org for set-up, breakdown, and other applicable rules.
- Non-profits must have a signed Hold Harmless Clause on file to participate in the Lilburn Farmers Market.
- Non-profit booth staff must arrive no later than 3:45 pm to set up their booth and stay until 8 pm.

The Lilburn Farmers Market will be held at Good Shepherd Presbyterian Church, 1400 Killian Hill Road, Lilburn, GA 30047.

The market is every Friday from June 5th to August 28th from 4 pm to 8 pm.
